



# **Endowment Committee 2016 Annual Report**

The Permanent Endowment Fund Committee is pleased to present this 2016 Annual Report to the congregation:

Established in 1994, the Endowment Fund is supported entirely by charitable gifts from the congregation, both lifetime and testamentary, as well as through investment of the gifts received. Its purpose is to fund special needs of the church and to support programs and ministries that are not funded by the regular giving of the congregation. Thirteen endowments make up the Endowment Fund, each having its own specified purpose, ranging from providing college and seminary scholarships and improving church facilities to supporting the church's music, youth, missions and other ministries.

Since its inception, the Committee has been focused on growing the size of the Endowment Fund to a level that would support making grants to fulfill its mission. Beginning in 2013, the Committee was in a position to begin making significant grants from the Endowment Fund, for two principal reasons.

First, as shown in this report, the balance of the Endowment Fund has increased significantly, from \$827,000 as of Dec. 31, 2011, to over \$2.5 million as of Dec. 31, 2015. This significant growth is largely due to the very generous \$1 million gift made to the Endowment Fund by Dorothy Ebersbach.

Second, changes in Florida law regulating endowments have allowed the Committee to establish a conservative annual spending policy for the Endowment Fund. As detailed in this report, under this policy for 2015, \$69,820 was granted from the Endowment Fund to fund scholarships, to support church ministries and to make improvements to church property. Set by the Committee in the fourth quarter of each year, the 2016 spending policy has allocated up to 3 percent of the September 30, 2015 fund value for distribution in 2016. This equates to a maximum distribution from the Endowment Fund of \$74,483 which is available to support the missions of the various endowments.

The congregation's support has taken the Endowment Fund to a level that it can have a current impact on the life and ministries of this church. We hope you find this report useful in understanding the Endowment Fund's mission and how the Committee is using the Endowment Fund to make God's love real in the life of this church.

#### Why an Endowment?

The Hyde Park United Methodist Permanent Endowment Fund was established in 1994 to provide a medium through which church members may provide permanent, financial gifts that will help support the future ministry of the church.

The earnings from these gifts, which may be cash or other assets, may be used to maintain the facilities and ministries of the church. An endowment gift may be made at any time, and is frequently made in honor or memory of an individual, or as part of an estate plan.

Endowment funds strengthen a church so that it may continue to empower its ministry even in difficult economic times. Funds are invested to grow over time and are managed by the Florida United Methodist Foundation. Because a prudent spending rate of only 2-3% is used in distributing funds, gifts make a lasting impact through the life of the church.

#### Giving to the Endowment Fund

You may make your gift to the General Fund within the Endowment Fund, or designate to a specific fund. Please specify how you would like your donation to be earmarked when planning your gift.


In the case of honorary or memorial tributes commemorating special persons or events, acknowledgments are mailed to both donors and honorees. Anonymous gifts are also accepted.

Types of gifts include cash, publicly-traded securities, closely-held securities, real property, tangible personal property, other property, bequests (wills), charitable remainder trusts, life estate gifts, life insurance, individual retirement accounts (IRAs), gift annuities and retirement plans.


#### "A Gift from the Heart" Planning Guide

#### 2015 Grants from the Endowment Fund

- \$9,649 Total in scholarships to fifteen undergraduate college students.
- \$27,353 Total in scholarships to four seminary students.
- \$1,475 Grant from the Missions Endowment to Florida United Methodist Conference's Imagine No Malaria campaign.
- \$12,736 Grant from the Facilities and General Endowments to construct and furnish a fellowship and gathering space outside the Magnolia Building
- \$3,204 Grant from the General Endowment to facilitate the worship experience by providing hymnal racks and envelope/pen holders to chairs in the Sanctuary and Chapel.
- \$2,612 Grant from the General Endowment for video editing equipment.
- \$2,119 Grant from the General Endowment to improve the Magnolia worship experience by providing two display televisions.
- \$10,672 Grant from the General Endowment to expand wireless Internet connectivity and replace aging backup equipment.

### The Fountain Fellowship

The Fountain Fellowship is composed of church members and friends who have indicated to the church they have included Hyde Park United Methodist in their will or estate plan.

The Fountain Fellowship uses the church's fountain as a symbol of gifts to the Endowment Fund that keep on giving, like a fountain of life-giving water.

The Endowment Committee hosts the Fountain Fellowship Dinner biannually to recognize and celebrate this commitment to the future ministry of the church.
